#### Landscaping

The Board reviewed a bid from ProCare to mulch some of the newly formed beds created by some aggressive pruning. This issue was tabled pending further clarification of the scope of contract.

## 2017 Pool Hours

The Board is dedicated to maximizing value to the homeowner, while carefully considering all costs, and trying to optimize revenues in order to ensure the self-sustainability of pool operations. Therefore, the Board reviewed extensive feedback / concerns from our homeowners regarding pool hours, guest passes, and other general services. After review, a motion was made by Don

Wyatt to approve the following summer pool hours. The motion was seconded by Brian Dell, and carried unanimously.

#### 2017 Pool Rates

The Board finalized discussion on the pool rates for 2017. Generally the rates will remain the same for 2017 with some exceptions. First, a \$25.00 discount will be offered on pool membership base fee compared to 2016 if homeowner's sign up PRIOR TO May 1<sup>st</sup>, 2017. After that date, the discount will no longer be in effect. Each primary membership will include a five-visit guest pass card. An additional five-visit guest pass card may be purchased for \$25.00 each. Details regarding pool memberships will be available in a soon to be released mailer. Prior to making these changes official, Don Wyatt made a motion to approve the aforementioned fees. Brian Dell seconded the motion and it carried unanimously.

## 7. Committee Reports

#### Community Events Committee

The CEC presented a list of events and a budget for the months of April to December, 2017. The purpose of the CEC is to add value to our community by increasing our 'sense' of community. After reviewing the list of events and budgetary items, Don Wyatt made a motion to approve the budget and the HOA funded portion. The motion was seconded by Brian Dell and carried unanimously.

#### 8. Old Business

#### Monument Repair

Phase two of monument repair will start soon with ten of our neighborhood monuments to receive tuck-pointing, brick replacement, or other general repair to help maintain the integrity of the

monuments and visual appeal for our neighborhood. The cost of maintenance will more than pay for itself by helping to prevent premature damage by further weathering to already damaged portions.

The Board will begin investigating bids for trash and recycling for calendar years 2018 and beyond.
